## **PCIJ Interview Guide**

Special Assistant to the President Christopher Lawrence T. Go As of July 2, 2018

Note: On June 5, 2018, we visited the office CLTG Builders and Alfrego Builders in Davao City. The owners were not present. We also sent letters on the same day. CLTG and Alfrego have not responded to the requests for comment despite multiple follow-up calls and emails, as of July 2, 2018.

1. Our review of the Department of Public Works and Highways (DPWH) data shows that CLTG Builders is one of the top contractors in the Davao Region. A secon company, Alfrego Builders & Supply, has also won DPWH contracts.

The rise of CLTG Builders as the principal contractor of some of the biggest projects in Davao coincides with the allotment of more money for roads in the region. Davao Region is the most blessed in civil-works projects among all regions in the country with an allocation of over P43.7 billion in 2017.

CLTG Builders bagged a total of P1.85 billion worth of infrastructure projects for the entire region from July 2010 to December 2017. This has yet to include the P2.7 billion worth of contracts won by CLTG through joint ventures with four other contractors, including Alfrego Builders. In total, CLTG won P4.6 billion worth of projects in the past seven years, more than half which was won just last year.

You are the son of Mr. Deciderio Go, the owner of CLTG Builders, and the half-brother of Mr. Alfredo Go, the owner of Alfrego Builders & Supply. CLTG and Alfrego had secured all their contracts while you were serving as executive assistant of former Davao City Mayor Rodrigo R. Duterte, and since June 30, 2016, as presidential assistant of President Duterte.

By most indications, CLTG and Alfrego could have been favored as contractors in the bailiwick of the Dutertes with whom you have worked closely since 1998. People on ground typically refer to the projects of the two companies as "projects ni Sec Bong Go." Please comment.

2. An analysis of records from the DPWH and the Philippine Government Electronic Procurement System (PhilGEPS) also shows that CLTG and Alfrego do not have the capacity to implement most of the projects they've won in 2017, the year when DPWH Region XI budget more than doubled. Nonetheless, the records also show that CLTG and Alfrego entered into joint ventures with bigger contractors. All of these joint venture projects are still incomplete, as of April 30, 2018, or well beyond the projects' deadline for completion. Deciderio Go is listed as the authorized managing officer of these joint ventures. *Please refer to the list in Annex A below.* 

Are you personally aware, or have been informed by your father and half-brother about these joint-venture contracts, and why these had all met with implementation delays?

To the best of your knowledge, what is the status of the projects awarded to the companies owned by your father and half-brother? Why did CLTG and Alfrego take on so many projects that they could not implement on their own and within project deadline?

3. President Rodrigo R. Duterte has expressed frustration over unfinished projects. In a January 2018 speech in Davao City, he ordered the DPWH to tell contractors to finish delayed projects in 30 days or have their contracts cancelled.

Davao is one of the regions with a significant number and value of incomplete projects. The region, which had the biggest allocation last year, posted a -2.05 delay rate in 2017. Of the 876 projects bidded out in Davao last year, 186 are still ongoing, while three have yet to start.

Is the President aware of this situation? Is the president aware that the contractors who have not completed the projects are closely related to you? How do you plan to address this problem?

4. Multiple sources privy to procurement activities in Davao say backroom deals are happening in order for certain contractors to corner contracts. Our sources say that CLTG Builders is among these contractors. Our sources also tell us that CLTG gets contracts and then transfers these to other contractors after getting a 10 to 30 percent share of project cost. Please comment.
